Notice of the Annual General Meeting

Dear Resident,

We are delighted to invite you to the **Annual General Meeting** for Leybourne Grange Management CIC on **Tuesday 23rd September, 6:30pm (from 6.00pm for registration and refreshments) 2025 at The Sports Pavilion**, Bannister way. Please read in full the important information below that relates to the General Meeting.

This is your AGM Pack which includes a copy of the final CIC Income Accounts together with the draft minutes of the informal community meeting (mtg not quorate) held on 24th September 2024 and the EGM on January 21st January 2025.

We welcome your attendance at the AGM, where we will present the 2024 Accounts for both the Service Charge and CIC. We will also be providing a summary of our priorities for the remainder of the year, as well as providing an update on progress against our Business Plan over the last nine months.

Unfortunately, we are unable to provide the full *draft* Service Charge accounts with your AGM notice today. We intended to send them to you prior to the AGM but on reflection feel they would be better presented in person at the AGM.

We hope you will accept our apologies for any inconvenience caused.

Leaseholders And Voting Rights

You may remember that in 2024 we received clarification that leaseholders **CAN** vote at the AGM, this position remains the same with our amended Articles of Association, approved in January 2025 and we welcome leaseholders to attend this meeting to cast your vote.

We would like to remind residents though that Housing Association tenants **CANNOT** vote as the membership of the CIC resides with the Housing Association. This is enshrined in the Community Trust Declaration. Housing Association tenants are, however, very welcome to attend the AGM too, hear of the CIC's work and meet the directors and staff team.

The AGM and Directors

When you purchased your property on Leybourne Chase, you agreed to contribute to the upkeep of community facilities through payment of the Service Charge, follow certain rules, and participate in managing the company, either as a Member or as a director.

To conduct any business at our AGM, we need approximately **27 households to attend** (final quorum number to be confirmed before the start of the meeting). Your participation is crucial – so please attend and register to vote. At the AGM, you will be able to approve the previous minutes, receive and note the 2024 accounts, hear about the Board's plans, and share your ideas or concerns in an informal session after the meeting. Please note, it is intended to re-appoint the same auditors and therefore no vote is required on this matter.

The AGM is a great chance to meet the directors and get to know them as fellow residents. The staff employed by the Board of Directors will also be present to answer any questions you may have and are looking forward to meeting you. This year, we are delighted to have Len Mayatt onboard, the new Community Operations Manager. Len will be present and is looking forward to meeting you.

Tatum Michaels-Carter from Preim will be attending remotely. Tatum apologies for this but has to out of the country for personal reasons. We are very grateful to her, however, for attending remotely. She will be at The Residents Surgeries to the held the following week. Please see below for further information.

We are always keen to hear from residents who may be interested in becoming directors to broaden the skills base of the Board, bring local passion, ideas and views to the table and provide greater resilience and capacity to support the governance of LGM CIC. SallyAnne Logan is the Independent (non-voting) Chair (appointed by the Board January 2024). She is not a director registered at Companies House and has no voting rights. Her role is to coordinate LGM CIC governance, providing advice, support and capacity to the Board of directors.

Voting

Each household is entitled to one vote. While the first person listed on the register (alphabetically by first name) is technically the voter, either registered resident can vote if both agree. However, if you are **in debt to the CIC AND legal proceedings are under way to recover that debt**, (Service Charge or other debt), you **cannot** vote. In order to vote, you must clear the debt by 5pm on 22nd September and have provided evidence to the CIC that you have done so.

We need approximately **27 households** (exact number to be confirmed before the start of the AGM) at the meeting to be quorate. Proxy votes do not count towards this number. Please register your attendance via email (len@leybournechase.org) to help us ensure we can hold a valid AGM.

Even if we don't reach the quorum, the meeting will continue informally covering the same business.

If you live in a shared ownership property, you can vote as a Member. Unfortunately, tenants of Housing Associations cannot vote because their Housing Association is the registered Member. However, **all** residents are welcome to attend the AGM and input into the discussions.

Finally, if you have any questions you would like to raise at the AGM, please email them to us beforehand (len@leybournechase.org) so that we can give you a full response on the evening.

- 3. A proxy does not need to be a member of the Company but must attend the meeting to represent you. If you wish to appoint a proxy other than the Company Secretary, delete "Company Secretary" and insert their full name in the space provided. If you leave this space blank, the Company Secretary will be appointed your proxy. Where you appoint as your proxy someone other than the Company Secretary, you are responsible for ensuring that they attend the meeting and are aware of your voting intentions.
- 4. To direct your proxy how to vote on the resolutions mark the appropriate box with an "X". If no voting indication is given, your proxy will vote or abstain from voting at their discretion. Your proxy will vote (or abstain from voting) as they think fit in relation to any other matter which is put before the meeting, including a motion to adjourn.
